**Aurela Anastas** is Professor of Constitutional Law at the University of Tirana since 1987 and a defense attorney specializing in women's human rights. She finished university studies in 1987 at Tirana, received the title Doctor in Law in 1995, the title Associated Professor in 1999, and Professor in 2005. She is

a member of the Academy of Sciences of Albania since 2009. She is author and co-author of several publications related to constitutional law, human rights, gender issues, and freedom of religion, including several textbooks and articles, papers and speeches. She has been involved in research projects, studies and working groups preparing legal acts, such as on the Constitutional reform of the justice system in Albania, on gender equality and protection from discrimination and domestic violence, on the draft-agreement between the Council of Ministers and the religious communities in Albania, and on the reform for academic research institution in Albania. She received the title Lawyer in 1996, and has worked at the Center for Legal Civic Initiatives since 2000 as a defense attorney specializing in women's human rights issues.


