CONCEPT NOTE

The School of Law, Christ University will host a symposium on "Forced Migration and Climate Justice" on March 6, 2025, providing a platform for global discourse on the critical nexus between climate change and forced migration. Climate change has emerged as a significant driver of displacement, compelling people to move due to both sudden environmental events like floods and hurricanes, and slow-onset changes such as rising sea levels and desertification. This type of migration is distinct from economic migration due to its involuntary nature, urgency, and lack of clear destinations, often leaving affected populations vulnerable and marginalized.

Displaced individuals face a range of challenges, including increased exposure to climate risks, socio-economic instability, and limited adaptive capacity. Slow-onset climate changes, while gradual, exacerbate existing vulnerabilities, undermining livelihoods and forcing migration as a last resort. These dynamics highlight the inadequacies of current legal frameworks, which often fail to address the unique needs of climate migrants, leaving them without adequate protections or recognition.

The symposium will explore the intersections of climate change, migration, and vulnerability, focusing on themes such as

- The New Normal: Examining weather extremes and their impact on communities.
- Psychological Impacts of Forced Migration: Highlighting mental health challenges faced by displaced populations.
- Emerging Legal Frameworks: Evaluating current laws and proposing reforms for climate migrant protection.
- Ethics of Climate Migration: Discussing moral imperatives for justice and equitable solutions.

This event aims to foster interdisciplinary dialogue and inspire actionable solutions through awareness, advocacy, and policy reform, reflecting Christ University's commitment to addressing global challenges. By engaging diverse perspectives, the symposium seeks to contribute to sustainable and equitable approaches to climate-induced displacement.

PROGRAM ON GLOBAL ETHICS AND SOCIAL TRUST (GEST)

Boston College's Program on Global Ethics and Social Trust (GEST) is an international initiative that brings together faculty across disciplinary and institutional boundaries to address the ethical dimensions of pressing global challenges and their implications for academic, political, and religious communities. The GEST Program's faculty working groups, including The Working Group on Climate Change and Migration, are sponsoring this symposium, which is partially funded by GEST. The Program on Global Ethics and Social Trust is a pilot project launched with the support of Porticus to enhance the multidisciplinary approach to global issues in Catholic universities worldwide. It is an initiative of the Provost's Office in partnership with the Office of Global Engagement and the Schiller Institute for Integrated Science and Society.

In the pilot phase, two working groups of scholars from predominantly Catholic research universities on five continents will investigate the role of global ethics and social trust in the problems of—and our responses to—climate-driven migration and democratic education. The goal of these working groups is not to "solve" these deep-seated problems but rather to create better ways of addressing them across academic and professional boundaries. By learning to look at issues that threaten our world from multiple perspectives, we open our own areas of inquiry to a new and forgiving critique of how we so often proceed.

- To exemplify effective ways of addressing urgent global issues across academic and professional boundaries in our work as teachers, scholars, and engaged citizens
- To ensure that diverse global insights and ethical perspectives are brought to bear as we do that work, rebuilding social trust in the process
- To foster multi-disciplinary collaboration and formative education among Catholic research universities around the world

ABOUT THE UNIVERSITY

CHRIST (Deemed to be University) was born out of the educational vision of St Kuriakose Elias Chavara, an educationalist and social reformer of the nineteenth century in South India. He founded the first Catholic indigenous congregation, Carmelites of Mary Immaculate (CMI), in 1831 which administers CHRIST (Deemed to be University). CHRIST (Deemed to be University) was established as 'Christ College' in 1969. It undertook path-breaking initiatives in Indian higher education with the introduction of innovative and modern curricula, insistence on academic discipline, imparting of Holistic Education and adoption of global higher education practices with the support of creative and dedicated staff."

The University Grants Commission (UGC) of India conferred Autonomy to Christ College in 2004 and identified it as an Institution with Potential for Excellence in 2006. In 2008 under Section 3 of the UGC Act, 1956, the Ministry of Human Resource Development of the Government of India, declared the institution a Deemed to be University, in the name and style of Christ University. One of the first institutions in India to be accredited in 1998 by the National Assessment and Accreditation Council (NAAC), Government of India, and subsequently in 2004, 2016, 2022 CHRIST (Deemed to be University) is currently accredited with 'A+' Grade.
