**A Resolution Concerning the Institutional Preventive Measures Against Coronavirus Risks, Racist Sentiment, and the Provision of Adequate Mental Health Care**

## LEGAL PREAMBLE

**Whereas:** Article 4, Section 2, Sub Point B of the UGBC Constitution states that “The Student Assembly shall be the final authority on all matters of policy, which concern the UGBC.”

**Whereas:** Article 4, Section 2, Point E of the UGBC Constitution states that “The Student Assembly shall have the power to make recommendations to other legislative and administrative bodies and officials concerning the welfare of the General Student Body.”

## SITUATIONAL PREAMBLE

**Noting:** As of February 4, 2020, at 12:00 GMT, there have been 20,696 confirmed cases of Coronavirus, of which 2,790 patients are in critical condition<sup>1</sup>. The death toll reached to 427, and 97% of all fatalities took place in Hubei province<sup>2</sup>.

**Further Noting:** The Massachusetts Department of Public Health confirmed on February 1, 2020, that a man in his early twenties has confirmed a novel Coronavirus infection after returning to Boston from Wuhan on January 28, 2020<sup>3</sup>.

**Further Noting:** The viral incubation period is believed by researchers to last up to 14 days for infections of the Novel Coronavirus 2019-nCoV<sup>4</sup>.

**Further Noting:** As the number of confirmed Coronavirus cases continues to grow globally, local and mainstream media<sup>5</sup> have reported a rise in racist stereotyping, abuse, and sentiment against Chinese people and people of Asian descent in public areas and on college campuses.

## OPERATIVE TEXT

**Therefore, be it resolved,** the Undergraduate Government of Boston College calls upon the University to implement the following measures to support the physical and emotional wellbeing of its students during the global coronavirus outbreak.

The following action items are proposed and passed by the Student Assembly (Senate):

- 1) Individuals who have recently returned from China should have timely access to University Health Services and all other requisite administrative services. Deans, professors, and academic advisors should work closely with those students choosing to self-isolate to make appropriate academic arrangements that will ensure they are not disadvantaged because of this choice.
- 2) The University should adopt a travel disclosure form similar to that which has been adopted by other Boston-area institutions<sup>6</sup> to ensure that it can actively respond to any concerns raised by its students.
- 3) The Office of Health Promotion and/or other administrative departments should make hand sanitizers, tissues, and facemasks available for free across campuses, destigmatize the use of these products by students, and advocate for rigorous sanitary practices, as well as employ other necessary precautions to prevent cross-infections among its members.
- 4) The Office of International Students and Scholars and University Counseling Services should partner with all parties concerned, including the Chinese Students and Scholars Association, Chinese Students Association, and Asian Caucus. Together, the organizations should actively reach out to and engage with students who have family members in the affected Chinese regions or who are experiencing increased anxiety or stress related to concerns about their families in China or about the deteriorating situation in their home-country.

The University should ensure students with increasing emotional stress aware of the mental health support from staff psychologists and peer mentors. Moreover, it should encourage faculty, academic advisors, and staff proficient in Mandarin Chinese or familiar with Chinese cultures and values to provide extra office hours for students to be able to discuss their worries and anxiety in their native language.

- 5) The Office of International Students and Scholars, the Office of Institutional Diversity, and related University departments should proactively combat undergraduate students' potential fear, racial bias, xenophobia, and anti-Chinese sentiment fueled by the spread of Coronavirus infections towards students of Asian descent on campus. Additionally, the University should take a firmer stance on the oversight and adjudication of incidents of racial discrimination against Asian (-American) students as a result of the coronavirus outbreak.
