- Dual degree students must complete 21 credits of LSEHD coursework for the master's degree.
- The courses listed on this form that will count toward the dual degree must reflect content coverage which allows the student to participate in experiences which reflect the issues at the intersection of business and higher education administration. Student should select courses that allow an opportunity to promote their interdisciplinary inquiry; all cross-listed business and education courses should be taken under the ELHE number rather than the CGSOM number so that students can achieve the required 21 credits of LSEHD coursework for the master's degree.
- Students should plan to take both electives (6 credits) in the Graduate Business School. The additional 3 credits from the Graduate Business School should be an appropriate substitution for one of the LSEHD requirements.
