"Chronicles of the Family Andreini: A Not Entirely Untrue Story of Renaissances and Reformations in Italy." This book concerns the machinations of the Andreini family – from the actors to the alchemists – as they earned respect for themselves and the theatrical profession in the middle of the Counter-Reformation. Reckoning with many tall tales the Andreini told about themselves, even in legal contexts, this study freely acknowledges what we can and cannot know in an empirical way, and shares hypotheses and hunches with readers throughout – albeit always signposted as such! At one level a family history in four generations, at another a tour of the Renaissance and Reformation eras, this book ultimately becomes a sustained reflection on the often (but in this case especially) porous boundaries between story and history.
