### PERSPECTIVES ON WESTERN CULTURE (14 sections, 2013-2021)

Year-long Great Books course that examines the Western philosophical and theological traditions with a view to the question, “What is the best way to live?” Focus on classical and modern political philosophy and ethics. Authors include Plato, Aristotle, Augustine, Aquinas, Hobbes, Machiavelli, Locke, Rousseau, Kant, Mill, Wollstonecraft, Marx, Nietzsche, and Freud.

### ENERGY JUSTICE: ETHICS, ECONOMICS, AND THE ENVIRONMENT

Study of the moral challenges that lie at the intersection of climate change, geopolitics, and economic development that approaches energy through an integral framework that includes humanities perspectives such as history, ethics, and philosophy. Considers energy as a physical, biological, and social phenomenon, examining the role of energy throughout human history and how societies’ mode of energy capture shapes their values and culture.

#### HOW TO SAVE THE WORLD: ETHICS OF CLIMATE CHANGE

Investigation of the ethics of climate change in relation to climate science, economics, energy policy, psychology, and national and international politics and policy. (4 Sections, Spring 2018, Fall 2019, Fall 2021, Fall 2022)

#### FORGING JUST CLIMATE POLICY IN THE UN COP PROCESS (Fall 2022)

An overview of the UN Climate Change Conference (COP) from an historical, political, and social perspective. The 1-credit course is required for student members of BC's official delegation to COP27 and open to other interested students through departmental permission. Particular attention will be applied to viewing the COP proceedings through three frames: climate change policy, health, and social justice.

#### SCIENCE AND ETHICS OF CLIMATE CHANGE (Spring 2017)

Team-taught interdisciplinary course examining the foundations of climate science, the moral and policy dimensions of climate change, and the relationships between them.

#### ENVIRONMENTAL ETHICS (Spring 2015, Spring 2016)

Inquiry into ethical theory focusing on normative theories related to the environment, such as anthropocentrism, biocentrism, and ecocentrism; consideration of economic, political, scientific, and ethical dimensions of contemporary environmental problems such as hydraulic fracturing, renewable energy, and climate change.

#### HUMANITY'S PLACE IN NATURE (Fall 2016)

Introduction to philosophy and ethics that focuses on the connections between nature and ethics. Examines the evolution of the idea of nature throughout the Western tradition through studying key ancient, medieval, and modern thinkers such as Aristotle, Aquinas, Bacon, and Darwin. Includes a primer on environmental ethics in preparation for the spring semester on climate change.

#### PHILOSOPHY AS A WAY OF LIFE (2 sections, Fall 2019, Fall 2020)

Presents philosophy in the spirit of French scholar Pierre Hadot's notion of philosophy a "way of life," an inherently practical discipline designed to help people flourish. In addition to examining and evaluating philosophical texts, students experiment with various reflective practices to get a sense for what it might be like to live like a philosopher. Examines six paths: three Western traditions—Aristotelianism, Epicureanism, and Stoicism--and three Eastern traditions—Buddhism, Confucianism, and Taoism.

#### PLAYING GOD: TECHNOLOGY AND THE HUMAN CONDITION

Introduction to the philosophy of technology that examines the history of technology; literature (Shelley's *Frankenstein*); classical (Aristotle, Marx, and Bacon), modern (Heidegger, Jonas, Dreyfus), and contemporary thinkers (Nicholas Carr, Jaron Lanier, Nick Bostrum); film (e.g., *The Matrix*, *Minority Report*, *Her*); and television (*Black Mirror*). We focus on the existential and ethical issues raised by digital technology, particularly the internet, smart phones, social media, data surveillance, artificial intelligence, and transhumanism. (2 sections, Fall 2019 and 2021)

SELF-KNOWLEDGE AND DISCERNMENT (Spring 2019)

A study of the philosophical and spiritual dimensions of walking and pilgrimage that culminates in taking the class to Spain to walk the Camino de Santiago. Authors include Rousseau, Thoreau, Nietzsche, and traditions such as contemplative Christianity and Zen Buddhism.

KORU MINDFULNESS (6 sections, Fall 2017, Fall 2018, Fall 2019, Fall 2021)

A non-credit, four-week course teaching an evidence-based curriculum in meditation and mindfulness skills for college student.
