Fathers' adverse childhood experiences (ACEs) and offspring health and wellbeing

As fathers are increasingly more involved in childrearing and play a critical role in child development, it is important that we better understand the influence fathers have on their children's health and wellbeing. To advance the knowledge base of paternal preconception factors that influence fathering and children's health, I examine associations between fathers' ACEs, fathers' behavioral health, fathering practices, and offspring health. I also examine the role of ACEs experienced within the parent-dyad, including the average experience of ACEs and incongruence in experience of ACEs, on children's health.
