### Transdisciplinary Initiatives

Data Analytics for Social Impact (Social Work, Nursing, Education, & Economics) Summer Hawkins (Lead)

The aim is to train a cohort of interdisciplinary thinkers in the use of big data in society. This project will address the growing trends of big data and data science that are in demand by graduate students and employers across sectors, but currently minimally covered in current graduate programs at BC, particularly those in the social and behavioral sciences. While faculty are engaged in these issues within individual schools and departments, we are currently not harnessing the full capacity of collaborations across BC to inform both research and teaching. The project brings together a core group of interdisciplinary faculty through trainings in data analytics.

## Systems Approaches for Environmental Health

Boston College School of Social Work (BCSSW), the Schiller Institute for Integrated Science and Society, and NIH's Implementation Science Network (ISN) for Clean Cooking at Fogarty International Center hosted a workshop to advance systems science approaches to understand and intervene in environmental health issues. We convened a small group of researchers in the environmental health field, specifically household air pollution (HAP) and water, sanitation and hygiene (WASH), with systems science experts to explore innovative ways these approaches can improve environmental health research and implementation. Our objective is to produce a manuscript to stimulate further thinking, and potentially future work using systems approaches toward these two major global health problems.

### Million Souls Project

Model the dynamics and evaluate the implementation and outcome from deploying seven million solar lamps to rural households across five states in India. Joint project between the Indian Institute of Technology-Bombay and Boston College School of Social Work.

# Social, Ecological, and Livelihood Systems Modeling (SEAL)

Model the social, ecological, and livelihood dynamics in rural poor communities of Rajasthan and Andhra Pradesh, India in collaboration with the Foundation for Ecological Security (FES), India. Funding from the Packard Foundation to FES, India. BC School of Social Work and Washington University Social System Design Lab are bringing Community Based System Dynamics expertise to this project.

# Harnessing Big Data for Environment, Livelihoods, and Population Wellbeing in India

This project will advance cross-school collaborations at Washington University to understand and engage in big-data analytics in the context of critical environment, human, and climate challenges on the ground in India. This is only possible because faculty from multiple disciplines across the campus will have the opportunity to convene in India with FES to explore the challenge of harnessing approximately 50 years of data on rainfall, forest ecosystems, surface and ground water resources, household and community data.

(Leading the Initiative, Funding from Brown School, McDonnell Academy)

The **ENPOWER**<sup>H</sup> initiative will focus the efforts of three McDonnell Academy partner universities (Washington University, University of Queensland, and the Tata Institute of Social Sciences) to understand and address development challenges that lie at the crossroads of environment, energy, food-water security, and health critical for sustaining productive livelihoods. This joint effort between our universities reaffirms the Academy's goal to address key global challenges of energy and environment, water and food security, and health. A signature feature of this partnership will be its geography specific emphasis with a clear focus on trans-disciplinary research, education, and problem solving, all of which are mutually reinforcing. Over the next 10 years, **ENPOWER**<sup>H</sup> initiative led by the three partner universities will aim to generate systematic research, educational initiatives, and engage in the dissemination and implementation of innovative programs and interventions in India and on campus. The research, education, and practice innovations will be geared toward improving social, economic, health, environment, food and water security foundational to sustainable livelihoods of the rural population, demonstrating an approach to enhance wellbeing of people in impoverished regions

and districts. Our initiative will provide particular attention to gender and economic vulnerability in our pursuit of sustainable environment, food, water, and health outcomes. The program will be place based and early focus will be in specific communities in the States of Andhra Pradesh and Telangana, India.

Real Option Strategies for Achieving Scale (ROSAS) — Household air pollution (HAP) presents one of the most pressing public health issues currently facing society. About 3 billion people rely on solid fuel combustion for their main cooking and energy needs. Women and children are disproportionately impacted by HAP exposure due to the amount of time spent near domestic hearths. Recent evidence points to the fact that instead of switching to exclusive use of clean fuels, a much more typical pattern was "stacking" where households continued the use of polluting fires and traditional fuels alongside new, cleaner technologies. The health impacts of clean cookstoves cannot be realized through cleaner technology and improved access alone, but will require a better understanding of household behavior
