TEACHING & MENTORING EXPERIENCE

Boston College Courses Developed for the Latinx Communities Field of Practice

SCWK7723: Re-thinking Diversity: Systems of Oppression & Privilege

Offered as a foundation requirement for all students in the MSW program, this course provides students with awareness, knowledge, and skills for social work practice in complex social systems. The important constructs of this course include anti-oppressive practice, anti-Blackness, systemic racism, white supremacy, the social construction of difference, intersectionality, power, and oppression. This course focuses on the root causes of bigotry to examine the adaptive strength of populations that are systematically denied access to opportunities for advancement. Students will understand how systems use cultural values, beliefs, attitudes, and behaviors to deny access to opportunities to certain populations. Students should complete this course with a better understanding of

the systems of oppression in which they will be working, as well as with the foundational skills needed to dismantle such systems.

SCWK 8837-01 Social Services with Latinx Populations in the US

This course is designed to provide an applied approach to social work with Latinx populations in the United States. Students learn specific skills and competencies to work with a variety of Latinx communities in different contexts. Barriers and best practices to social services such as education and healthcare are discussed throughout the course. Additionally, causal pathways to systemic inequity such as discrimination, legalization, racialization, and criminalization of Latinx communities as well as evidence-based best practices in response to pressing community needs will be presented throughout the semester.

SCWK7777 Services to Migrants: A Border Perspective

This experiential learning course in Tucson, Arizona, seeks to deepen students' understanding of the causes and difficulties of migration, as well as the impact of immigration policies on peoples' lives. Students will engage with immigrant-led organizations in experiential workshops designed to provide a range of skills for effective social work with immigrant communities.
