TERMS AND CONDITIONS OF PARTICIPATION

1. Fees and Payments: Upon acceptance into the travel program, I agree to pay any deposit required by the sponsoring department. I commit to any fundraising that may be required by the program to cover expenses. I understand that the program does not cover expenses for passports, visas, medical services, or recommended immunizations, and that I am responsible for all expenses not covered by the program. I understand that if I withdraw from the program for any reason or if I am removed because of my conduct, no refunds will be given to me or to those who donated in my name.

2. Health: I certify that I am aware of the immunizations, vaccinations, and any other travel health recommendations of my doctor and the Centers for Disease Control and Prevention (“CDC”) for travel to the destination(s) listed above. I have consulted with my doctor regarding any pre-existing conditions that may affect my ability to participate in the trip. I take sole responsibility for following my doctor’s and the CDC’s recommendations. I have disclosed to the trip leader or if applicable, to Disability Services, any health conditions that may require accommodations or additional support in connection with the travel program.

3. Insurance. I certify that I will maintain health insurance during the travel program and that my health insurance covers medical expenses, including hospitalizations and physician care, in throughout the United States. I agree to purchase any additional insurance required by the University in connection with an international travel program.

4. Conduct: I understand and accept that while participating in the program I will remain enrolled as a degree candidate at the University and, as such, I agree to adhere to the University's Code of Conduct as set forth in the Boston College Student Guide. I understand and agree to observe the laws of the country in which I will be residing, as well as any other rules imposed by the trip leader and any host institution. If I do not abide by these regulations and rules as interpreted by the trip leader or host organization, I agree that I may be subject to appropriate disciplinary action, including, without limitation, early termination of my participation of the program. If I am terminated, I will return as soon as possible to Boston College or my primary residence at my sole cost and expense.

5. Travel Risks: I understand that participation in the program involves risks not found in study at Boston College. These may include, without limitation, risks associated with traveling to and within, and returning from, other locations; political, legal, social and economic conditions; different standards of safety in other locations; poor traveling conditions and road safety, and local weather conditions. The locations to which I will travel may have health and safety standards substantially different from those of the United States or Boston College, and I recognize that I may be subjected to potential risks, illnesses, injuries, and even death.

I understand that the University does not represent or act as an agent for, and cannot control the acts or omissions of, any host organization, transportation carrier, hotel, tour organizer or other provider of food, goods or services involved in the program. I understand that the University is not responsible for matters that are beyond its control, and that it cannot warrant the safety or convenience of the circumstances under which I will be living or working.

I understand that travel can be unpredictable and situations may become volatile and dangerous, often within a very short period of time. I understand that in such circumstances, evacuation or avoidance may prove difficult or impossible. I further understand that I should avoid situations that have the potential for becoming politically volatile or otherwise dangerous.

6. Informed Consent and Release: I believe that I am fully and adequately informed of the risks inherent in the travel experience. If I am traveling abroad, I have read the relevant U.S. Department of State Travel Advisories and Consular Information Sheets. I have weighed the dangers inherent in the program, the risks presented to my own health and well being, and my personal desire to further my educational experiences by traveling and working in another location. I have had the opportunity to ask questions which have been answered to my satisfaction. I have shared and discussed these materials and information with a parent or legal guardian. I acknowledge that there may be additional risks which may not have been brought to my attention. With this knowledge and information, I agree to participate in the program, and the travel, solely at my own risk.

To the maximum extent permitted by law, I release, hold harmless and agree to indemnify the University, and its officers, directors, faculty, staff, representatives, employees and agents, from and against any present or future claim, loss or liability for injury to person or property which I may suffer, or for which I may be liable to any other person, related to my participation in the program (including periods in transit to or from my destination), resulting from any cause, including but not limited to negligence.

I acknowledge that my participation is voluntary and is not required as part of my education at the University. In consideration for the University allowing me to participate, I voluntarily assume all risks arising out of my participation in the travel program listed above.
